

Orlando Trip Contract & Payment Option Form

DUE SEPTEMBER 1st, 2010

Payment Option One – NO Fundraising

We choose to pay \$1065 for the 2012 band trip to Orlando, Florida by the deadline. We understand that the \$105 deposit is non-refundable. We opt out of all TRIP fundraising opportunities.

Under this option payment may be made by one lump payment OR by monthly payments according to the payment schedule set forth by the Band Directors.

Payment Option Two – Fundraising

How it Works: If a student participates in the fundraising option the dollars earned will go into a pool to reduce the overall cost of the spring trip for all students choosing to participate in fundraisers. This money is split equally amongst all that completed the minimum 15 fundraising points.

We will pay the \$105 trip deposit and understand that it is non-refundable. We agree to participate by earning a minimum of 15 fundraising points to help lower the cost of the trip for all students choosing Option Two. We understand that fundraising may not cover the total cost of the trip and agree to pay the balance needed by the deadlines. If we do not achieve the 15 required fundraising points, we will be REQUIRED to pay the full trip amount or forfeit going on the trip.

Under this option, a set monthly payment will be due according to the schedule set forth by the Band Directors. Year two payment schedules (2011-2012) may be adjusted based on the amount of money in the fundraising pool.

I will NOT be going on the Trip to Orlando

REFUNDS:

As in the past, any money that you pay towards the trip will be held for your student's trip expense. So, if you pay the total amount of the trip it will go to your student. If a relative gives money towards the trip it will go to that student's trip expense. If a student backs out of the trip by the 'drop date' you will be refunded all amounts you paid less the non-refundable deposit.
